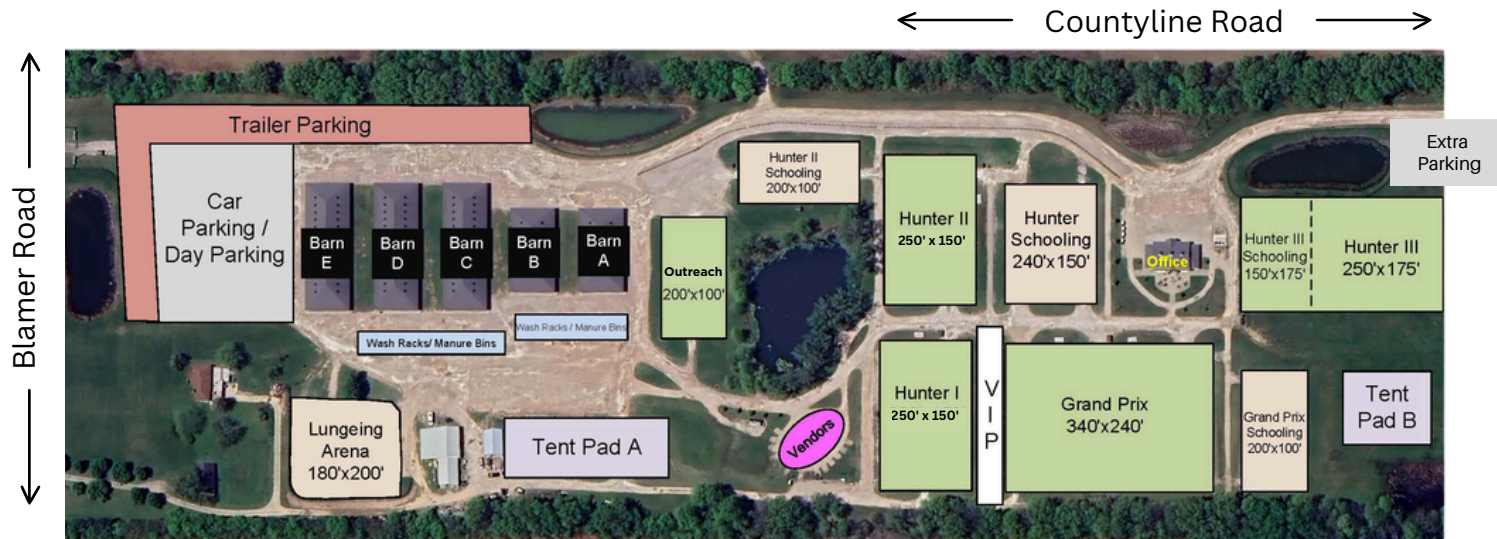

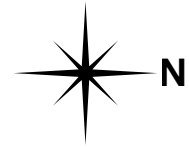

### CONDITIONS OF COMPETITION United States Equestrian Federation

*EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.*

#### USEF Membership Statement

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee.

Participants in the following classes are exempted from the Requirements of this rule:

- 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

#### Federation Entry Agreement

By entering a Federation-licensed competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulteur or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of The BraveHorse Show Series (Competition).

I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable-casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

The Horse Show Committee reserves the right to itself to interpret all questions and conditions in regard to or arising out of or incident to the show without claims for damages or recourse of any kind. ALL questions not covered in these Rules and Regulations shall be decided by the Horse Show Management; its decision to be final.

The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interest of the show and its exhibitors. Every horse entered for competition will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its members, directors and employees, contractors, sponsoring entities and facility harmless for any loss or accident to horse, horses or equipment which may occur from sickness, fire or otherwise. Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.

Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation. No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform. It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitable presented to appear before an audience.

**STABLING:** 10' X 12' permanent stalls with stall doors, the floors are screenings with rubber mats and 10' x 10' temporary stalls on concrete with rubber mats. Stalls for horses are \$250 inclusive of night watch, and must be prepaid or reserved with a valid credit card. Temporary stabling 10' x 10' of vinyl construction with doors and under canvas will be used for additional stabling if necessary. Stalls in the permanent barns (permanent or temporary) will be reserved first come first served. Initial bedding will not be provided. Any stall not occupied by a horse will be considered as at Tack Stall and billed at \$250.00. Stalls will be available at 9:00 am the morning preceding the scheduled start date and must be vacated by the following Monday at 9 am. Any Tent stalls with a pole should be used for grooming or tack, NOT a horse stall.

All stall reservations, bedding orders, hay orders and camper reservations will be online.

***Stall requests must be finalized 14 days before the first day of the show.***

***No stalls will be reserved without a check or credit card authorization.***

***No refunds after the closing date.***

**SHIP-IN FEE:** Horses that have not purchased a stall will be subject to a \$75.00 Ship-In Fee.

**OFFICE/ADMINISTRATION FEE:** Each horse will pay a **non-refundable** \$135 Administration fee. All horses occupying a stall, whether showing or not are required to pay the administration fee.

Hay and shavings available at Market price plus Licking County Sales Tax. Any use of offsite shavings will result in a \$50.00 disposal fee. **Please keep your back number for the 2026 show season.**

**NON-SHOWING HORSES:** All non-showing horses must have completed and signed an entry blank. Non-showing horses will pay a \$150.00 non-showing fee. Competing in 3 classes, or at least \$150 in entry fees will be considered a showing horse. Scratched horses on the grounds are considered non-showing horses regardless of the reason.

**HORSE SHOW OFFICE:** The office will open 1 hour prior to the start of the show each day and close at 4:00 PM or 30 minutes after the last class finishes, whichever comes first. Adds for the following day must be completed before the office closes.

**RETURNED CHECKS:** A processing fee of 10% or \$30.00 minimum will be assessed for all non-negotiable checks. A 3% convenience fee will be charged for credit card transactions.

**PRIZE MONEY:** An IRS/W9 needs to be completed showing the proper prize money recipient and their SS or FED ID#. Care must be taken to be sure the information matches that of the IRS. Prize money will be deducted from your account upon closeout in the office provided you have filled out the required IRS/W9. Balances will be paid in the form of a check at the show or may be mailed to the named recipient on the W9 within 30 days after the conclusion of the show. The IRS W9 form is available in the show office. Any credit due will be mailed within 30 days following each show.

***No prize money will be mailed unless the owner's (or other designated payee's) social security number and complete address are listed on the entry blank.***

**CREDENTIALS:** USEF / USHJA Membership, Amateur and Measurement Cards. This show will be electronically verified with the USEF provided you have submitted a COMPLETE entry blank, including all required numbers and signatures, you will not be required to show us your membership cards, measurement cards, or recording cards. We WILL NOT look up your numbers for you. If you have recently applied online, you will be given an instant number so include it on your entry. Please do not mail Memberships to USEF, they will not be electronically verifiable for weeks and we will be required to charge you non-member fees. Incomplete entry forms will be charged a fee of \$25 (considered late entry) and will be required to show proof of membership, etc. before your number is released. No numbers will be released until proper credentials, a valid form of payment and all signatures of owner, rider or handler and trainer are in order. All Pony or Junior Hunters who do not possess a current measurement card will be measured at a time and place to be announced. All horses competing in US Equestrian Federation recognized competitions (except those activities enumerated in GR901.9) must be properly identified and must obtain a USHJA horse identification number. USHJA Horse Registration - \$75.00. Any change of horse's name and/or ownership must be recorded with the Federation. Mandatory Microchipping went into effect on December 1, 2018. **You will not be allowed to COMPETE on any horse that has not been micro-chipped with the exception of OUTREACH. Microchips must be properly recorded with USHJA.**

**CLOSING DATES:** *Stall counts must be finalized 14 days before the show. No stall will be reserved without a check or credit card authorization. No refunds after the closing date.* If you are mailing an entry, it must be received no later than 7 days before the show to avoid a late fee and online entries must be submitted by 5:00 pm, Monday prior to the show. Faxed entries cannot be accepted. Post entries will be accepted at regular cost plus a one-time late charge of \$25.00. There is no penalty for adding classes or changing horses (same owner) at the show.

**NO mailed entries.**

**All entries must be done online.**

**Outreach signatures may be asked for in office.**

Exhibitors are responsible for knowledge of the Rules and Regulations governing the Horse Show and for their own errors and omissions. In the case of a violation of a cross entry restriction, the exhibitor will forfeit the entry fee and class placing.

**BRAVE HORSE SHOW PARK ARENA:** Seven (7) of the Brave Horse Show Park's arenas are a blend of SRS footing. Grand Prix Ring 340 x 240, Grand Prix Schooling 100 x 200, Hunter Ring I 250 x 150, Main Hunter Schooling 240 x 150, Hunter Ring II 250 x 150, Hunter II Schooling 100 x 200, Barn A Arena 100 x 200. There is a sand footing Longeing Area 180 x 200.

**ADDING CLASSES:** **No Same Day Ads,** (Same day adds **require** management approval). **Entries due by 4:00pm the day before the classes are scheduled.** See RDNE fees.

**SCRATCHING CLASSES:** This **MUST BE DONE IN THE SHOW OFFICE** or your **horseshowsonline** account, or an official add/scratch slip. Full credit will only be given for any classes scratched before the start of the division. Informing the starter that you do not intend to participate does not get you scratched in the office and will not qualify for a refund.

**RDNE (Rode Did Not Enter):** Entries that show in a class that was not properly entered either online, by inclusion on your original entry, or a properly filled out add slip **PRIOR** to the class involved will be charged a \$15 RDNE Fee. This charge will show on your statement as "entered off judge's card". All class adds must be completed by 4:00 P.M. the day before the class in question to assure acceptance.

**SCHOOLING:** Schooling in the show rings without permission is prohibited at all times. There will be a \$100 fine for anyone caught in the rings before or after the show if rings have been closed. The rings will only be available for hacking in the mornings, **weather permitting.** The number of horses in the ring at one time may be limited for safety.

**LONGEING:** IN OFFICIAL LONGEING AREAS ONLY - NO LONGEING PERMITTED IN ANY OF THE SHOW RINGS AT ANY TIME

**HUNTER COURSES:** Fences will simulate obstacles found in the hunt field, such as brush, post and rails, walls, in and out, gates, etc. No bank or water jumps. Course diagrams will be posted no later than 30 minutes before the class. In some cases, the area of the courtesy circle may be restricted by a dotted line. Under Saddle classes to be shown at a walk, trot and canter both ways of the ring. No martingales permitted. In High Performance, A/O and Junior classes, entries may be asked to hand gallop collectively one way of the ring, at the Judge's discretion. No more than eight shall be asked to hand gallop at one time.

**POLING:** Manual poling and use of bamboo offsets are prohibited at all times while on the show grounds. Exhibitors found in violation will forfeit all entry fees for that showing day or day afterwards and may be excluded from showing for 24 hours upon any incident recorded with Management and the USEF Steward.

**JUMPING ORDER:** A rotating jumping order will be established with the starter. Exhibitors must check in with the Starter to establish an order of go. There will be a posted order for all jumper classics and medal classes. Riders and/or trainers who have conflicts due to multiple entries in a class must see the starter so that necessary adjustments can be made. In classes where horses compete collectively, a warning is issued and the in-gate must be closed THREE minutes after the first horse enters the ring. Judging will commence when the gate is closed or at the end of the three-minute call.

**CHAMPION & RESERVE CHAMPION AWARDS:** Ribbons awarded to 8th place in all classes except where noted.

A Champion and Reserve champion for each eligible hunter division is to be determined after the last class for each division, consisting of at least three over fences and one under saddle. The determination is to be done in a manner consistent with current USEF specifications. The top four horses or ponies from those receiving points over fences also receive any points from the under saddle class.

The top two are then the show Champion and Reserve Champion. In the event of a tie, the horse with the most points over fences will be the Champion. Points are assigned in this manner: 1st=10, 2nd=6, 3rd=4, 4th=2, 5th=1, 6th=1/2.

A Jumper Champion and Reserve Champion will be awarded after the last class for each section (training classes excluded). Classics will count as the third or fourth class of sections and be awarded bonus points. ALL CLASSICS WILL BE COUNTED AS TOWARDS CHAMPIONSHIP WITH BONUS POINTS AWARDED, AND THE CLASSIC WILL BE THE TIE BREAKER FOR ANY TIES FOR CH/RES

**PROTECTIVE HEADGEAR: ALL EXHIBITORS MUST WEAR ASTM APPROVED HEADGEAR AT ALL TIMES WHILE MOUNTED.**

It is compulsory for all persons at Federation licensed hunter, jumper or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM/SEI standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. Exception: In Hunter or Jumper classes, adults may be allowed to remove their headgear while accepting prizes and during the playing of the National Anthem only; they must refasten their headgear prior to the lap of honor. While competing in a jumping class, if a rider's chin strap becomes unfastened, the rider may stop, re-fasten the chin strap and continue his/her round without penalty or elimination. A judge may, but is not required, to stop a rider and ask them to refasten a chin strap which has become unfastened, again without penalty to the rider.

**REFUNDS:** Entries cancelled prior to the closing date will be refunded in full. Stalls and processing fees are not refundable for any reason after the closing date of entries. All entry scratches must be submitted in writing to be considered for a refund. All accounts become final after the close of the show, changes will not be considered after this date, no exceptions. Please look over your statement carefully before checking out. If the show must be stopped due to a storm, accident or other emergency, the show management has the right to deny a refund of any or all fees.

**DOGS:** Dogs are not permitted to be loose on competition grounds at any time and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule must/will be issued a Yellow warning card by the steward or any competition official. Immediately following the receipt by the Federation of a third Yellow Warning Card indicating that a competitor, spectator, or participant has been issued three (3) Yellow Warning Cards within a (16) month period the Executive Director shall either levy a fine ranging from \$500 to \$1000 or a formal Charge pursuant to this Rule and GR604 alleging that the rules have been violated on all or any one of said three occasions pursuant to Chapter 6 of the Rules.

**MEDICAL WASTE:** In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste container will be provided in the stable area. Failure to use them will result in a \$100 fine per needle found. All exhibitors and their agents are responsible for the proper disposal of medical waste.

**PLEASE DO NOT MIX NEEDLES WITH THE MANURE OR TRASH**

**AIR VESTS:** Air vests are allowed (and encouraged) in all disciplines. For hunter and equitation classes, judges are instructed to not deduct points for the use of an air vest. Please understand the show will not be delayed in order to reset the air vest. Riders who choose to wear air vests are therefore strongly encouraged to have spare equipment (air canisters, tethers, and entire vest) ringside so that the vests that have been inflated can quickly be returned to operation. Air vests are permitted without a show coat ONLY if being worn with a color matched, long sleeve, collared shirt.

**EARBUDS:** Earbuds or earphones are prohibited while mounted in any areas designated for schooling and exercising including lunging areas.

**COVID-19 GUIDELINES:** State of Ohio and Licking County Covid 19 Guidelines will be strictly enforced. Updates provided at [www.horsespot.net](http://www.horsespot.net) and at [www.brave-horse.com](http://www.brave-horse.com).

### USEF WAIVER

Everyone, including parents, grooms, guests, etc. must sign a USEF Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, this can be done on [horseshowsonline](http://horseshowsonline) at the time you do your entries. Forms are available at [horseshowsonline](http://horseshowsonline) or [www.usef.org](http://www.usef.org).

### MOTORIZED VEHICLE STATEMENT

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions.

Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

### STATEMENT AS TO FEDERATION FEE

(GR407.1-3) For every horse participating in any competition licensed by the Federation, a \$35 Federation Fee will be collected (\$15 shall be an Equine Drugs & Medication Fee to provide for research, inspection and enforcement of rules regarding use of medications and drugs).

Exception: Horses entered in classes exempted from the Equine Drugs and Medication fee are also exempt from the balance of the Federation fee.

### SAFE SPORT STATEMENT

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for Safe Sport training requirements to be eligible to participate in the competition. All participants must adhere to the U.S. Center for Safe Sport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org). As of Jan 1, 2019 every USEF adult member (18 years of age or older) with a Competing Membership must complete USEF's Safe Sport Training. You will do this when logged into your USEF account, preferably when you renew your membership. Failure to complete the Safe Sport training will disqualify you from competing in any capacity until it is completed. Junior riders that have reached their 18th Birthday must complete the Safe Sport requirements.

Protecting the health of your horse and other horses at Brave Horse is of the utmost importance to us. Brave Horse has implemented Required Biosecurity Measures to decrease the risk of introduction and/or spread of contagious or infectious disease at its shows.

### HEALTH CERTIFICATE

#### REQUIRED

The Ohio Department of Agriculture requires each horse coming from out of state to have a valid Certificate of Veterinary Inspection (Health Certificate) dated within the prior 30 days of entry into Ohio with the following address listed as the Premises of Destination: **Brave Horse, 1029 South Countyline Rd., Johnstown, OH 43031.**

### NEGATIVE COGGINS

#### REQUIRED

Dated within twelve months (365 days) of the ending date of each show. This includes horses that originate from the state where the event is being held. All horses entering the Show Grounds must have a Negative Coggins on file. Coggins must reflect the horse's SHOW NAME.

### EVENT PARTICIPATION DECLARATION

#### REQUIRED

Signed by the owner/agent/trainer verifying that the horse has been healthy with no sign of infectious disease and has not had a fever above 102°F within 72 hours (3 days) of arrival. Event Participation Declaration Form available in this prize list and at BraveHorse.com.

A new Event Participation Declaration Form must be filed each time the horse enters the property. Horses stabled off the property that "ship-in" on a regular basis must comply with this requirement as well as additional requirements noted on the following pages.

### PROOF OF VACCINATION

#### REQUIRED

Via a signed statement from the attending veterinarian that the horse has been vaccinated against the following:

- Within 6 months (180 days) of each show: Equine Influenza (EIV)
- Within 6 months (180 days) of each show: Rhinopneumonitis (EHV 1 and EHV 4)

If a vaccination will expire during one of the shows, the horse must receive its new vaccination prior to being issued a competition number for that show.

### PRESENTATION OF HEALTH REQUIREMENTS

The Equine Health Requirements are Required for all horses entering the Show Grounds both Showing and Non-Showing. These documents must be filed in the Show Office before any competition numbers will be issued. In addition, random checks by Ohio State Veterinarians for Equine Health Requirements will occur. Be sure to keep a copy of all of your horse's Equine Health Requirements in an easily accessible spot (in your tack room or tack trunk, truck or trailer) to ensure you can comply with this requirement. The results on all required papers must indicate the horse's registered (show)name. HORSE INFORMATION CAN BE UPLOADED VIA EQUITRACE DIRECTLY TO HORSE SHOW.

Any horse not accompanied by these documents will be directed to the Show Veterinarian to obtain the required documents and/or vaccinations, and/or will be placed in quarantined stabling until the proper documents are obtained. Any horse showing signs of fever/illness/stress is subject to examination by Brave Horse Officials and/or the Show Veterinarian, who may at their sole discretion, place the horse in quarantined stabling or take further action if deemed necessary.

**ANY HORSE WITH A FEVER OF 102° OR GREATER MUST IMMEDIATELY BE REPORTED TO SHOW MANAGER AND VET**

### SHIP - INS

Any Horse entering the Brave Horse Show Grounds property, showing or non-showing, must abide by the Equine Health Requirements as set forth in the prize list. In addition, horses that ship-in daily for their classes, for warm-ups, or that are on the grounds for any reason and do not reside in a stall on the show grounds must also abide by the following:

Health Documentation: All haul in horses (showing or non-showing) must file the proper Health Requirements in the show office, and must be prepared to present those health records at any time while on the show grounds. Ship-ins/day trippers will be subject to random checks by Brave Horse Officials and/or Staff.

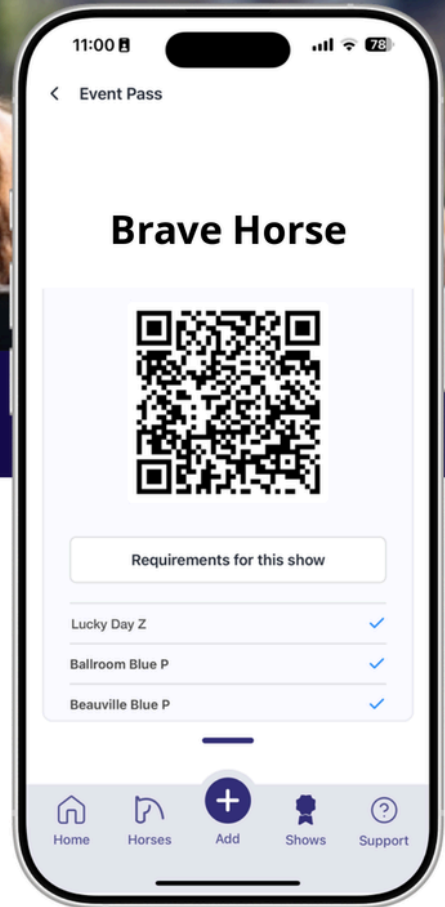

If proper records are not immediately available, the horse(s) a.) must remain under Brave Horse Staff observation until the paperwork is presented, or b.) will be asked to leave the grounds. Riders competing in the Amateur-Owner Hunter sections may compete on one (1) different horse in the Adult Amateur Hunter section. Horses can not cross enter into the 3'3" or 3'6" Amateur-Owner Hunter sections at the same competition. 3'0" with spreads not to exceed the fence height. Courses will not be adjusted for ponies. **CHILDREN'S HUNTER:** A Children's Hunter Horse rider may only compete on one (1) different horse in the Junior Hunter Section. Riders entered in the Children's Hunter Horse sections may not compete in any other class in which obstacles exceed 3'5" at the same competition (exception: Equitation classes up to 3'9", Jumper classes 1.20m and lower, Junior Hunter sections and the USHJA International Hunter Derby). Riders entered in the Children's Hunter Horse section may only compete on one (1) Children's Hunter Pony at the same competition. 3'0" with spreads not to exceed the fence height. Courses will not be adjusted for ponies. Combinations will be permitted. Handy Hunter classes are optional and can be added at the competition management's discretion.

**CHILDREN'S HUNTER PONY:** Riders competing in the Children's Hunter Pony section are limited to the number of ponies they may show, providing they are not also competing in the Green or Regular Hunter Pony sections and/or Children's Hunter Horse section at the same competition (exception: competitions which limit entries in accordance with GR915). If a rider competing in the Children's Hunter Pony section chooses to compete in sections other than Children's Hunter Pony at the same competition, these riders are limited to competing a maximum of one (1) different pony in the Green or Regular Pony Hunter section and one (1) horse in the Children's Hunter Horse section at the same competition and in any class not to exceed 3'5".

**LOW ADULT HUNTER:** Open to horses and ponies ridden by adult riders who are considered amateurs according to USEF rules. Riders may not cross-enter at the same show into any class or sections where fences exceed 3'0" (Exception: All Age Group Equitation Classes) Riders who compete in the 3' Adult Amateur Hunter Section may show one horse in the Low Adult Amateur Hunter Section. Horse and Rider Combination: Low Adult Amateur Hunter Horse/rider combinations may not cross enter into any classes or section where the fences exceed 2'9" at the same competition. (Exception: All Age Group Equitation)

**LOW CHILDREN'S HUNTER:** Open to horses and ponies ridden by junior riders according to USEF rules. Rider may not cross-enter into the Pony Hunter section or any class or section where fences exceed 3'0" (Exception: All Age Group Equitation Classes) Riders who compete in the 3' Children's Hunter Horse Section may show one horse in the Low Children's Hunter Horse Section. Horse and Rider Combination: Low Children's Hunter Horse/rider combinations may not cross enter into any classes or section where the fences exceed 2'9" at the same competition. (Exception: All Age Group Equitation)

**USHJA HUNTERS:** A horse and/or rider may only compete in one (1) section of the height. No more than two (2) sections may be judged at the same time. Contiguous height sections may be combined if there are fewer than three (3) entries in a class. Heights must be clearly marked. All sections must be open to horses and ponies.

**USHJA HUNTER 2'6"/2'9"/3'0":** Combinations are permitted. To be shown over a course of eight (8) fences.

**USHJA HUNTER 2'0"/2'3":** Oxers are options, combinations are not permitted. To be shown over a course of eight (8) fences.

**PRE-CHILD/ADULT HUNTERS 2'3"**: Open to horses and ponies ridden by riders who are considered amateurs according to USEF rules.

**LOW PONY HUNTERS 2'0"**: Open to exhibitors who have not reached their 18th birthday as of December 1, 2024. **FUTURE HUNTERS**: Open to riders of any age on beginner horses or ponies that have never shown over 2'0".

**SPLITTING/COMBINING: IMPORTANT INFORMATION CONCERNING SPLITTING/COMBINING & ADD/SCRATCH POLICY IN ALL "A" RATED HUNTER SECTIONS** - Should entries warrant, all "A" rated hunter sections will be split or combined following USEF rules and will be done so at the close of the horse show office on the evening preceding the first class is each section, therefore entries **MUST** be completed for "A" rated hunter divisions accordingly to be considered. Any post-adds received and accepted after this time will not be considered in respect to the splitting/combining numbers.

There will be no exceptions to this policy.

Same day scratches and/or "no-shows" at the gate in all "A" rated hunter sections will forfeit their entry fee unless a Certificate from the Official Show Veterinarian vet scratch for the show is received by the official show secretary prior to the First class of the section in question.

Should same day scratches or no-shows result in insufficient entries to keep sections split, sections will be combined.

**"A" HUNTER SECTION ENTRY FEES**: After showing in the first class of any "A" rated section requiring a section entry fee, no refunds will be given for scratching any classes within the section for any reason.

**JOG**: Horses/ponies are required to trot a circle on a loose rein at the end of each over fences performance. Horses/ponies may be asked to return to the ring and trot another circle at the judge's discretion. Option B: Horses/ponies will be jogged together with the rider unmounted in the judge's order of preference.

### **PROPER ATTIRE:**

All exhibitors must be correctly attired in accordance with current USEF rules governing hunter, jumper, and equitation divisions. In hunter and equitation classes, riders are required to wear traditional show attire consisting of a conservatively colored hunt coat, breeches, a collared shirt with choker or ratcatcher, tall field boots (or paddock boots with garters where age-appropriate), and a properly fitted, secured ASTM/SEI-certified protective helmet with harness fastened at all times when mounted. In jumper classes, riders must wear a secured ASTM/SEI-certified helmet and traditional show attire; hunt coats are required unless management announces that jackets are waived due to weather conditions. Sleeveless shirts are prohibited unless jackets are officially waived. All attire must be neat, clean, and in good repair. Management reserves the right to bar any exhibitor from entering the ring who is not in compliance with proper attire regulations.

**NOMINATION FEE**: Level 2 - \$150 nomination fee / Level 3 - \$175 nomination fee / Level 4 - \$200 nomination fee on all horses showing in Jumper Classes and Classics at 1.00m and above (*unless otherwise noted*). Please refer to jumper classes for additional nomination fees. **Once a horse is nominated, the nominating fee is NOT refundable.**

The USHJA Outreach Program has been established to engage and connect hunter and jumper riders, trainers and horse owners with the USHJA by providing the opportunity to participate in USHJA branded classes and competitions

Classes are open to Juniors, Amateurs or Professionals on horses or ponies. No cross entry restrictions.

Note: Ponies ridden by Amateurs or Professionals may not show in Pony Classes at the same show.

Management reserves the right to combine classes as necessary.

USEF/USHJA membership is not required to compete in these classes, but USHJA Membership is needed for points to count toward year-end awards.\*

Membership at the USHJA Outreach level for Riders is **free**; USHJA Registration for Horses is \$20 per Year, or \$75 for Life.

**The US Equestrian Board of Directors approved a new microchipping rule during the 2023 Mid-Year Board meeting. Beginning December 1, 2026, under GR 1101.10, all horses competing in USEF-licensed or -endorsed competitions must be microchipped with a 15-digit ISO compliant 11784/11785 chip.**

\*Any rider may compete in Outreach hunter, jumper, and equitation classes, but riders wishing to earn points and national recognition, must be USHJA free Outreach member or higher. Competitors with a USHJA free Outreach membership or higher will be eligible to earn year-end awards and rewards in hunters, jumpers and equitation.

Rewards for competing in any USHJA Outreach Class (Hunter, Equitation, and Jumper) will be based on total points earned. Riders achieving a Bronze, Silver, or Gold point level will be eligible to redeem their points at year-end for items of their choice: USHJA logo wear, Bronze, Silver, or Gold Outreach ribbons or Outreach medallions.

- **High Point Awards:** The highest pointed Gold level rider in each Zone will earn the Golden Back Stage Pass to participate in USHJA National Championship Affiliate Sections, and will be invited to participate in the Grand Prix Show Jumping and Hunter Derby course walks, and educational sessions.
- **Trainers Awards.** Trainers who are USHJA free Outreach members or higher will be awarded points based on their students competing in Outreach classes (student must be a USHJA free Outreach members or higher). One trainer from each Zone whose riders have earned 100 or more points cumulatively, will be recognized as the USHJA Outreach High Point Trainer.
- **Horse Awards.** Owners of horses competing in Outreach Competitions and Classes wishing to have their horses earn points towards awards must register their horse with USHJA (\$20/year or \$75 lifetime). Horses are not required to be registered with USHJA or microchipped to compete in Outreach classes.

Shirts must have a white collar and white cuffs. Shirts must be fastened at the neck and tucked into breeches. Boots are required. Half chaps are permitted as long as the color matches the paddock boots being worn. Members of the Armed Services or the police may wear the service dress uniform with protective headgear. (See General Rules, GR801.3)

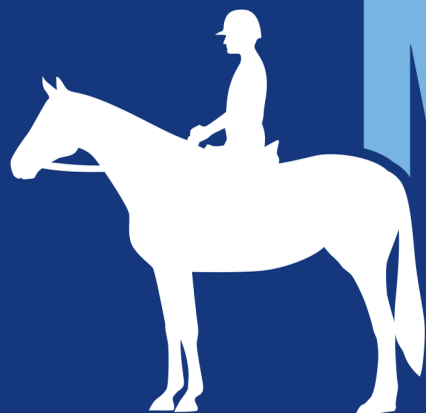
**Proper Jumper Attire.** Coats of any color are required. Breeches must be light color (white, fawn or canary). Pastel and dark colored breeches are not allowed. Shirts, light in color, must be tucked into breeches and fastened at the top of the neck. Ties or chokers of any color must be worn (unless the shirt, by design, has the choker built in for its intended use). Boots are required. Half chaps are permitted as long as the color matches the paddock boots being worn.

**Standard Jumper Attire.** Coats are not required. Breeches of any color are permitted. Shirts (polo shirts are permitted) must have collars and sleeves (sleeves may be either long or short), and must be tucked into breeches. Sleeveless shirts and shirts with exposed hoods are prohibited. Boots are required. Half chaps are permitted as long as the color matches the paddock boots being worn.

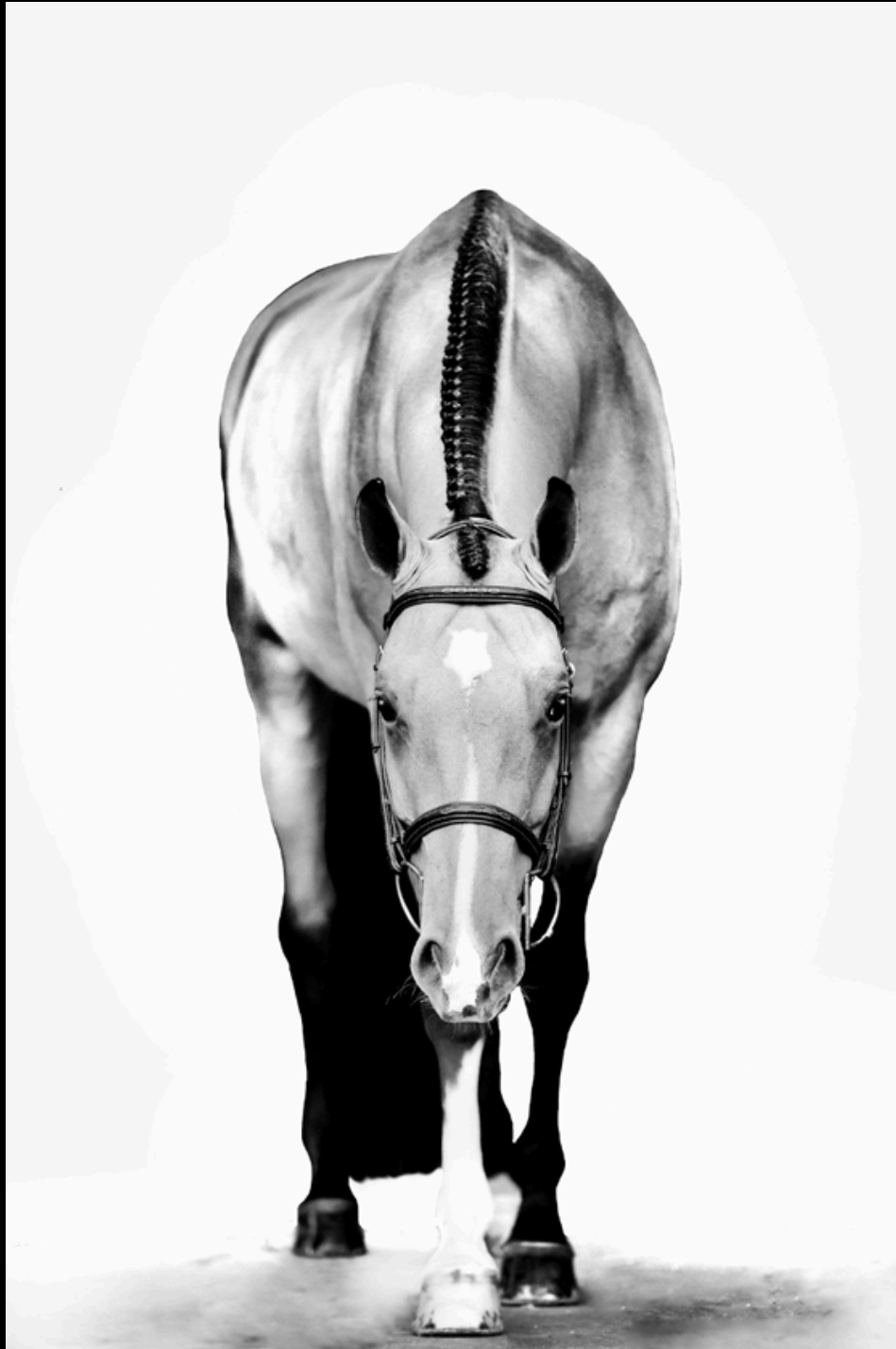
